- 1. agree to the additional resources for the Recycling & Waste service required to meet the growth pressures by implementing the 'Bridging Solution' as outlined in the report.
- agree to extend the contract with SUEZ to its full term to 2026 to provide the consistency and stability needed to implement the Bridging Solution and prepare for the outcomes of the Environment Act 2021.

RECOMMENDED to Council;

3. that the additional budget required is approved; a revenue budget increase of £1.25 million per year (£734,928 pro-rata for 2022/23) and estimated capital expenditure of £1.11 million to fund the changes to the service.

REASON:

A comprehensive business case was included in the Bridging Solution document providing the rationale and supporting data to explain the case for the expansion of the Recycling & Waste service and gives the revenue and capital budget provisions required to deliver the changes. The business case had been compiled jointly by the EDDC/SUEZ Partnership Team.

Consideration of risk to the Recycling and Waste service in the context of this report falls into four categories – Firstly risk to the service by not expanding the collection capacity.

This is summarised in Section 2 of the Bridging Solution document 'The Problem'. Secondly the

risks involved in the implementation of the Bridging Solution should it be approved. These

implementation risks are covered in Section 4.13 of the Bridging Solution document. The third

area of risk is a contractual risk. The contract with SUEZ includes the delivery of collection

services up to 73,000 properties at which point the contract change mechanism is triggered. It is

projected that 73,000 properties will be reached in the autumn of 2022. If collection services to

properties beyond 73,000 are not catered for by the Bridging Solution an alternative arrangement

would need to be made. Fourthly there is a risk that modification of the contract during its term

does not comply with the original procurement conditions. Legal advice has been sought on this

and the risk level has been assessed as low. The attached advice note from Bevan Brittan

provides more information. More information on the categories of risk are provided in the Risk

section of the full report below.
