# \*6 Schedule of application for Sub Committee approval where an agreed position has been reached and all parties have agreed a hearing is unnecessary

The Sub Committee gave consideration to an application for the grant of a premises licence where an agreed position had been reached and all parties had agreed that a hearing was unnecessary. The Chairman and Vice Chairman considered equality impacts when making their decision.

The Licensing Officer explained the background of the application and the negotiations that had been carried out.

#### Agreed position reached by the parties:

Following mediation the applicant and the two local residents have agreed that they consider a hearing to be unnecessary if the following agreed position is approved.

The application be approved as submitted subject to the following amendments:

- 1. The outside upper and lower patio areas as shown on the plan submitted to the Licensing Authority will close at 11pm daily.
- 2. Off sales of alcohol from the restaurant will be restricted to residents of the Hills Farm Complex.

3. Notices will be prominently displayed both inside and outside the premises requesting customers to keep the noise to a minimum and respect the residents and neighbours of the Hills Farm Complex.

### \*7 Hackney Carriage Suitability

The Sub Committee gave consideration to an application to license a 6 years and 5 month old Volkswagen Caddy car as a hackney carriage vehicle and to determine whether to refuse the application or to make an exception to the District Council's vehicle age policy and agree to license the vehicle. The vehicle fell outside of the criteria as agreed by the Council as it is over four years old from the date of registration. Members noted that the vehicle was wheelchair compliant and had previously been licensed by the applicant with Rochford District Council.

The Licensing Officer reported that there were only 10 other wheelchair compliant vehicles licensed in east devon (only two in Exmouth where the applicant intended to work) and there was a large customer demand within the district for these vehicles. In response to a request for a sign on the taxi rank at The Strand, Exmouth saying there was a wheelchair vehicle available from a member of the Sub Committee, the Licensing Manager reported that he would speak to Devon County Council, over whether they would allow such a sign.

#### **RESOLVED**

that the application be granted as an exception to the District Council's vehicle age policy and agrees to license the vehicle.

### Reasons

- 1. The vehicle supported the Council's equalities policy.
- 2. Need for wheelchair compliant vehicles in the community.
- 3. The vehicle was very well presented and in good condition with an AA report.
- 4. The vehicle had an existing licence with another Licensing Authority.

### Report in full

### 1 Description of Application

- 1.1 An application has been received from Punch Taverns Plc of Jubilee House, Second Avenue, Burton Upon Trent, Staffordshire, DE14 2WF, for the grant of a premises licence at the Balfour Arms, 26 Woolbrook Road, Sidmouth, Devon, EX10 9UZ.
- 1.2 The premises already have the benefit of a premises licence number PLWA0288 a copy of the existing premises licence is reproduced at **Appendix A**.
- 1.3 The existing timings and the proposed timings and licensable activities applied for in the new licence application are produced in table form at **Appendix B**.
- 1.4 A full copy of the application is reproduced at **Appendix C**.
- 1.5 A new licence application has been made primarily to allow an outside area of the premises to be licensed and to extend the opening hours to allow a start time of 8:30am to serve breakfasts. Included within in the new application are extra licensable activities indoors and outdoors for films, performance of dance and anything similar to live and recorded music and performance of dance. The live and recorded music is changed from indoors to indoors and outdoors and extended by one hour on Fridays and Saturdays but all licensable activities to cease outdoors by 11pm.
- 1.6 The proposed premises consists of a two storey detached building with a large beer garden to the side and rear of the property. The ground floor of the premises is open plan and set out as bar and restaurant areas. The premises is situated on the outskirts of Sidmouth in a mixed commercial and residential area.
- 1.7 A copy of the plan of the premises will be available at the meeting for the information of the committee to show the existing layout of the site and the areas of licensable activity.

- 3 Representations and Responses to Notices of Hearing

- 3.1 Representations have been received from the Councils Environmental Health Section and twelve local residents. Details of their representations are attached at **Appendix D**.
- 3.2 In view of calls received during the application period at the Licensing Office and some of the comments in the representations received a short update note to clarify some of the aspects of the application was included within the notice of hearing papers for the information of the objectors. A copy of this note is included at **Appendix E.**
- 3.3 Responses to notice of hearing forms have been received from three local residents who wish the hearing to go ahead on their paper representations but have indicated that they would <u>not</u> be attending the hearing. One other resident did not respond to the offer of mediation and has not returned their response to notice of hearing forms. The other nine objectors including the Environmental Health Officer reached an agreed position with the applicants at mediation and have withdrawn their representations and will not be attending the hearing. The applicants will be represented at the hearing by Martyn Clark Area Operations Manager for Punch Taverns Plc and Ron Miles manager and Designated Premises Supervisor of The Balfour Arms.
- 3.4 Details of the responses to the statutory Notice of Hearing are attached at **Appendix F.**

### 4 Proposed Operating Schedule and Mediation

- 4.1 A mediation meeting chaired by the Licensing Authority was held at The Balfour Arms at 10am on Friday 21 October 2016. The meeting was successful and the applicants agreed to an extra three conditions to be added to their licence in order that the nine objectors represented including the Environmental Health Officer could withdraw their representations. Details of the agreed position conditions are attached at **Appendix G**.
- 4.2 The conditions offered by the applicants on their operating schedule have been reproduced at **Appendix H** and have been numbered for ease of reference.

### 5 Relevant Licensing Policy Considerations

### **Licensing Objectives**

5.1 Section 3.1.1 of the Policy states: 'The Licensing Authority has a duty under the Act to carry out its licensing functions with a view to promoting the four licensing objectives.'

These are:-

	The prevention of crime and disorde
	Public safety
	The prevention of public nuisance
	The protection of children from harm

- 5.2 Section 3.1.2 of the policy states: These objectives are the only matters to be taken into account in determining the application and any conditions attached must be appropriate in achieving the licensing objectives.
- 5.3 Section 3.1.3 of the Policy states: A licence will only be granted where the Licensing Authority is satisfied that these objectives have been met.

### **Conditions**

- 5.4 Section 6 of the policy sets out what the Sub Committee should consider before imposing conditions on a licence.
- 5.5 Section 6.3 of the policy states: Generally it is recognised that the licensing function is not to be seen as a mechanism for the general control of anti-social behaviour by individuals/groups once they are beyond the direct control of the licence holder of any premises concerned. But the Licensing Authority's discretion may be engaged if relevant

representations are made and there is an evidential link between the disturbance and the licensed venue.

### **Licensing Hours**

- 5.6 Section 10.1 of the Policy states: The licensing authority will deal with the issue of licensing hours on the individual merits of each application. When the Authority's discretion is engaged consideration will be given to the individual merits of an application but the presumption will be to grant the hours requested unless there are objections to those hours raised by Responsible Authorities or any other person on the basis of the licensing objectives. However, when issuing a licence with hours beyond midnight higher standards of control will generally need to be included in operating schedules to promote the licensing objectives especially for premises which are situated near residential areas.
- 5.7 Section 10.4 of the Policy states: The terminal hours will normally be approved where the applicant can show that the proposal would not adversely affect the licensing objectives unless, after hearing relevant representation the licensing authority believe it necessary, proportionate and reasonable to restrict the hours required.

#### Nuisance

5.8 Section 16.1 of the Policy states: To promote the licensing objectives, applicants for licences for licensable activities will be required to demonstrate the measures they have in place for the prevention of public nuisance. The impact of the licensable activities on people living in the vicinity should not be disproportionate or unreasonable. The issues will mainly concern noise nuisance, light pollution, noxious smells and litter. The prevention of public nuisance can include low-level nuisance affecting a few people living locally as well as a major disturbance affecting the whole community. It may also include the prevention of the reduction of the living and working amenity and environment of interested parties.

### Capacity

- 5.9 Section 17.1 of the Policy states: Where it is considered necessary to control the maximum numbers of persons attending premises for the purpose of preventing crime and disorder or for public safety the licensing authority will expect this to be addressed in the operating schedule. The licensing authority, if relevant representations are made and only then if such conditions are deemed necessary, proportionate and reasonable, may impose a condition stipulating a maximum number of persons permitted to attend premises where it considers it necessary to prevent crime and disorder or for public safety purposes.
- 5.10 The **Guidance** issued under Section 182 Licensing Act 2003 states:

The licensing authority may not impose any conditions unless its discretion has been engaged following receipt of relevant representations and it has been satisfied at a hearing of the necessity to impose conditions. It may then only impose conditions that are appropriate to promote one or more of the four licensing objectives. Such conditions must also be expressed in unequivocal and unambiguous terms to avoid legal dispute.

It is perfectly possible that in certain cases, because the test is one of appropriate, where there are other legislative provisions which are relevant and must be observed by the applicant, no additional conditions at all are needed to promote the licensing objectives.

The Act requires that licensing conditions should be tailored to the size, style, characteristics and activities taking place at the premises concerned.

Licensing authorities should therefore ensure that any conditions they impose are only those which are appropriate for the promotion of the licensing objectives, which means that they must not go further than what is needed for that purpose.

Licensing authorities should only impose conditions which are appropriate and proportionate for the promotion for the licensing objectives. If other existing law already places certain statutory responsibilities on an employer or operator of premises, it cannot be appropriate to impose the same or similar duties.

#### 6. Observations

- 6.1 Following the implementation of the first set of regulations under the Police Reform and Social Responsibility Act on 25 April 2012 a new provision relating to the 'test' that Licensing Committees should consider when deciding on licensing applications was introduced. The evidential level for Licensing Committees has been lowered so that the test now is that their decisions need only be 'appropriate' and no longer 'necessary'.
- 6.2 The application being considered is for the grant of a Premises Licence to allow:

ш	Exhibition of films indoors & outdoors
	Live music indoors & outdoors
	Recorded music indoors & outdoors
	Performance of dance indoors & outdoors
	Anything similar to live & recorded music and performance of dance indoors &
	outdoors
	Late night refreshment indoors & outdoors
	Sale of alcohol on and off the premises

- 6.3 The premises already have the benefit of a premises licence (copied at **Appendix A**) however the current manager and Designated Premises Supervisor (DPS) Ron Miles has been using Temporary Events Notices (TENs) to licence an outside rear beer garden for alcohol sales and entertainment. He recently approached the Licensing Authority, Police and Environmental Health Team with a request to permanently licence the outside area. As a result it was determined that Punch Taverns Plc the licence holders would need to apply for a new licence for the whole premises to include the outside area to replace the existing licence. This application if granted would reduce the cost to the premises by not having to pay for numerous TENs and they would not be restricted on the number of times they could use the outside beer garden as they currently are under the TENs regime.
- 6.4 Although the primary reason for applying for the new licence was to include the outside area onto the premises licence the applicants have also applied to extend the existing opening hours in the morning to allow the premises to open at 8:30 am to provide breakfasts although the alcohol start time of 11am stays the same. They have also included extra licensable activities of films, performance of dance and anything similar to live and recorded music and performance of dance. They have also applied to extend live and recorded music on Friday and Saturday nights inside the premises by one hour to fall in line with the alcohol sales timings.
- 6.5 It should be noted that at the request of Environmental Health all licensable activities outside in the beer garden will cease at 11pm daily.
- 6.6 Following calls to the licensing office and the content of some of the representations received it was clear that some of the residents were not aware of the closing time of the current licence and the proposed closing time of the new application. Their calls/representations indicated that they believed that the applicants were applying for later closing times for the premises but that is not the case as the closing times on the application is the same as already exists on the current licence apart from extended hours on Maundy Thursday, Christmas Eve and Boxing Day which have been removed from the new application. As a

result a short note was included within the notice of hearing paperwork sent out to the objectors to clarify the position (**Appendix E**).

- 6.7 The concerns of nine of the objectors including the Environmental Health Officer were satisfied at mediation by an agreement from the applicants to offer three further conditions to be added to the licence (see **Appendix G**). Their concerns related to possible noise nuisance caused by amplified music in the beer garden as well as people noise from smokers currently using the front porch area of the premises. The applicants have offered to have a noise limiter fitted to the equipment in the outside area as well as setting up a smoking area in the beer garden with notices directing customers to this use this area rather than using the front porch.
- 6.8 The remaining four residents are concerned that any increase in hours will further aggravate noise and unacceptable anti social behaviour already taking place within the area. The concerns are that the premises will not be able to control 'people noise' when customers leave the pub late at night and that customers already remain in the front car park for up to an hour after closing time shouting and screaming till 1am. The concern is that if the extension for later hours on the weekends is granted the disturbance could be extended up to 2am. There is also a concern that as the premises only has a small car park customers are parking in nearby residential streets and disturb residents by slamming doors when leaving late at night.
- 6.9 The Sub Committee will now need to consider whether to grant this application as it stands or in the light of the representations to refuse the application or grant it in a different form.
- 6.10 A location plan is attached at **Appendix I**.

### Legal Advice

- 1. As relevant representations have been made in respect of the application, this hearing must be held. (Relevant representations are about the likely effect of the grant of the application on the promotion of the licensing objectives, by any person, bodies representing them or responsible authorities). The sub-committee must disregard any information or evidence not relevant to the licensing objectives.
- 2. The sub-committee must consider this application in accordance with Section 4 of the Licensing Act 2003, which requires that licensing functions must be carried out with a view to promoting the four licensing objectives. The licensing authority must also have regard to its own licensing policy and the Secretary of State's guidance, but may depart from both if it has good reason to do so. Those reasons should be stated.
- 3. Section 18 of the Act requires the licensing authority to grant a premises licence unless it considers additional steps are needed for the promotion of the licensing objectives having regard to any relevant representations.

### The steps are:

- (a) to grant the licence subject to:
  - (i) the conditions in the operating schedule modified to such extent as members consider necessary for the promotion of the licensing objectives, and
  - (ii) any condition which must under sections 19, 20 or 21 be included in the licence;
- (b) to exclude from the scope of the licence any of the licensable activities to which the application relates
- (c) to refuse to specify a person in the licence as the premises supervisor
- (d) to reject the application.

The conditions of the licence are modified if any are altered or omitted or any new condition is added. Different conditions may be applied to different parts of the premises, and to different licensable activities. The sub-committee must give its reasons for its decision to take any of these steps. Similarly, if any part of an application is rejected, the sub-committee must give its reasons.

**4.** The Act requires mandatory conditions to be imposed where supplying alcohol or exhibiting films are approved as licensed activities. It also requires a mandatory condition to be imposed where door supervisors or other individuals carrying out security activities are conditions on the licence.

### (a) Section 19 - Mandatory conditions relating to the supply of alcohol

- (a) There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
  - (b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
    - Source: Section 19 Licensing Act 2003
- 2. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises -
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
      - drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective.
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective.
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).

- 3. The responsible person shall ensure that free potable water is provided on request to customers where it is reasonably available.
- 4. (1) The premises licence holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and either
    - (a) a holographic mark, or
    - (b) an ultraviolet feature.
- 5. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml; and
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available.
- (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
  - (2) For the purposes of the condition set out in paragraph 7(1)
    - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula  $P = D + (D \times V)$

where—

- (i) P is the permitted price,
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence—
  - (i) the holder of the premises licence,

- (ii) the designated premises supervisor (if any) in respect of such a licence, or
- (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence;
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.
- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

- (b) Section 20 Mandatory condition relating to exhibition of films Children may only be admitted to films in accordance with the classification recommendations of the British Board of Film Classification, or as recommended by the licensing authority.
- (c) Section 21 Door Supervision—Not Required
  Where door supervisors are specified by condition, those individuals must be licensed by the SIA.
- 5. The sub-committee will need to consider the hours of operation proposed in relation to the licensable activities in the light of the promotion of the licensing objectives, the effectiveness of the operating schedule proposed by the applicant, the representations received, the location of the premises in relation to residential and other commercial properties including other licensed premises, the history of the management of the premises and how it is proposed to be run in the future, the evidence produced of any problems in the past, and the likely impact of any extension of hours and activities. These issues, and any other relevant ones, may be explored at the hearing.

### 6. Human Rights Act 1998

6.1 The sub-committee must also have regard to the provisions of the Human Rights Act 1998 when determining this application. The 1998 Act made the European Convention of Human Rights directly enforceable in British courts. The relevant provisions are Article 6 (right to a fair trial), Article 8 (right to respect for private and family life), Article 11 (freedom of association) and Article 1 of the First Protocol (right to peaceful enjoyment of one's possessions). These provisions are explained below. Essentially, they require the sub-committee to identify correctly the competing interests, give each appropriate weight in the circumstances of the case, and balance them against each other in order to arrive at a fair and reasonable decision.

- 6.2 Under Article 6, "everyone is entitled to a fair and public hearing within a reasonable time by an independent and impartial tribunal established by law". The procedures established by this Council for hearings under the Licensing Act 2003 are compliant with Article 6.
- 6.3 Under Article 8, "everyone has the right to respect for his private and family life, his home and his correspondence". This right may not be interfered with except in accordance with the law and as may be "necessary in a democratic society in the interests of national security, public safety or the economic well-being of the country, for the prevention of disorder or crime, for the protection of health or morals, or for the protection of the rights and freedoms of others". In Licensing Act cases this means that the sub-committee must have regard to the effect of its decisions on local residents, and balance their interests against those of the public at large (e.g. the customers of the premises under consideration) and the people operating the business from the premises.
- 6.4 Under Article 11, "everyone has the right to freedom of peaceful assembly and to freedom of association with others" except where it is lawful to restrict that freedom in the interests of national security or public safety, for the prevention of disorder or crime, for the protection of health or morals or for the protection of the rights and freedoms of others". In Licensing Act cases this means, for example, that the sub-committee is entitled to impose conditions to ensure that patrons of licensed premises do not unreasonably disturb others living or working nearby. Again, the sub-committee should balance the competing interests.
- 6.5 Article 1 of the First Protocol (that is, the first amendment to the Convention) says that every natural or legal person (meaning a human being or a company) is entitled to peaceful enjoyment of his possessions, except where the law provides for restrictions on that right in the public interest. This means, for example, that it is compliant with the Convention to impose restrictions, such as those provided in the Licensing Act 2003, upon business premises where it is in the public interest to do so. On the other hand the same applies to the owners and occupiers of neighbouring premises.

### 7. Appeals

If the sub-committee imposes conditions on the licence with which the applicant disagrees, or modifies the licensable activities permitted or refuses to specify a person a designated premises supervisor, he or she may appeal within 21 days of notification of the decision to the Magistrates' Court. The applicant may also appeal if an application for a premises licence is rejected. Those making relevant representations may appeal if they believe that the licence should not have been granted, or that, when granting the licence, the licensing authority ought to have imposed different or additional conditions or excluded a licensable activity or refused to specify a persona as designated premises supervisor. The magistrates' court may dismiss the appeal, or substitute its own decision, or send back the case to the licensing authority with directions as to how the case is to be dealt with. The magistrates' court may make any costs order it thinks fit.

### 8. Review Provisions

If extended hours/licensable activities are granted, the Licensing Act contains review provisions which enable any person, bodies representing them or any of the responsible authorities to apply to this licensing authority for a review of the licence. A hearing follows which enables the sub-committee to use the normal powers at a hearing (set out above) but also to suspend the licence for a period of up to three months or to revoke it.

### 9. Police Closure

A senior police officer may close any premises for 24 hours (this can be extended) where s/he reasonably believes there is or is likely imminently to be disorder on, or in or in the vicinity of the premises and their closure is necessary in the interests of public safety.

Closure can also be affected if public nuisance is being caused by noise coming from the premises and closure of the premises is necessary to prevent that nuisance

### 10. Surveillance Camera Code of Guidance-June 2013

Where a relevant authority has licensing functions and considers the use of surveillance camera systems as part of the conditions attached to a licence or certificate, it must in particular have regard to guiding principle one in this code. Any proposed imposition of a blanket requirement to attach surveillance camera conditions as part of the conditions attached to a licence or certificate is likely to give rise to concerns about the proportionality of such an approach and will require an appropriately strong justification and must be kept under regular review. Applications in relation to licensed premises must take into account the circumstances surrounding that application and whether a requirement to have a surveillance camera system is appropriate in that particular case. For example, it is unlikely that a trouble-free community pub would present a pressing need such that a surveillance camera condition would be justified. In such circumstances where a licence or certificate is granted subject to surveillance camera system conditions, the consideration of all other guiding principles in this code is a matter for the licensee as the system operator.

### Guiding principle one states:

Use of a surveillance camera system must always be for a specified purpose which is in pursuit of a legitimate aim and necessary to meet an identified pressing need.

Legitimate aim and necessity are considered in relation to the four licensing objectives which are set out elsewhere within this report if the Committee is considering conditioning any premises licence with the installation of a CCTV surveillance system.

### **ANNEXE 1 - MANDATORY CONDITIONS**

- (a) There shall be no sale or supply of alcohol when there is no designated premises supervisor in respect of this premises licence or at a time when the said premises supervisor does not hold a personal licence or when his/her licence is suspended.
  - (b) Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 2. (1) The responsible person must ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.
  - (2) In this paragraph, an irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises-
    - (a) games or other activities which require or encourage, or are designed to require or encourage, individuals to-
      - (i) drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or
      - (ii) drink as much alcohol as possible (whether within a time limit or otherwise);
    - (b) provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic in a manner which carries a significant risk of undermining a licensing objective:
    - (c) provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less in a manner which carries a significant risk of undermining a licensing objective;
    - (d) selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner:
    - (e) dispensing alcohol directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of disability).
- 3. The responsible person must ensure that free potable water is provided on request to customers where it is reasonably available.
- 4. (1) The premises licence holder or club premises certificate holder must ensure that an age verification policy is adopted in respect of the premises in relation to the sale or supply of alcohol.
  - (2) The designated premises supervisor in relation to the premises licence must ensure that the supply of alcohol at the premises is carried on in accordance with the age verification policy.
  - (3) The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and

either-

- (a) a holographic mark, or
- (b) an ultraviolet feature.
- 5. The responsible person must ensure that-
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures-
    - (i) beer or cider: ½ pint;
    - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
    - (iii) still wine in a glass: 125 ml;
  - (b) these measures are displayed in a menu, price list or other printed material which is available to customers on the premises; and
  - (c) where a customer does not in relation to a sale of alcohol specify the quantity of alcohol to be sold, the customer is made aware that these measures are available."
- 6. (1) A relevant person shall ensure that no alcohol is sold or supplied for consumption on or off the premises for a price which is less than the permitted price.
  - (2) For the purposes of the condition set out in paragraph 7(1) -
    - (a) "duty" is to be construed in accordance with the Alcoholic Liquor Duties Act 1979;
    - (b) "permitted price" is the price found by applying the formula -

$$P = D + (D \times V)$$

#### where-

- (i) P is the permitted price.
- (ii) D is the amount of duty chargeable in relation to the alcohol as if the duty were charged on the date of the sale or supply of the alcohol, and
- (iii) V is the rate of value added tax chargeable in relation to the alcohol as if the value added tax were charged on the date of the sale or supply of the alcohol;
- (c) "relevant person" means, in relation to premises in respect of which there is in force a premises licence-
  - (i) the holder of the premises licence.
  - (ii) the designated premises supervisor (if any) in respect of such a licence, or
  - (iii) the personal licence holder who makes or authorises a supply of alcohol under such a licence:
- (d) "relevant person" means, in relation to premises in respect of which there is in force a club premises certificate, any member or officer of the club present on the premises in a capacity which enables the member or officer to prevent the supply in question; and
- (e) "value added tax" means value added tax charged in accordance with the Value Added Tax Act 1994.
- (3) Where the permitted price given by Paragraph (b) of paragraph 2 would (apart from this paragraph) not be a whole number of pennies, the price given by that sub-paragraph shall

be taken to be the price actually given by that sub-paragraph rounded up to the nearest penny.

- (4) (1) Sub-paragraph (2) applies where the permitted price given by Paragraph (b) of paragraph 2 on a day ("the first day") would be different from the permitted price on the next day ("the second day") as a result of a change to the rate of duty or value added tax.
  - (2) The permitted price which would apply on the first day applies to sales or supplies of alcohol which take place before the expiry of the period of 14 days beginning on the second day.

### ANNEXE 2 - CONDITIONS CONSISTENT WITH THE OPERATING SCHEDULE

- 1. There will be a 30 minute wind down period following the cessation of the supply of alcohol on the premises, on the expiry of which the premises will close.
- 2. Membership of the Local Licensees Association will be maintained.
- 3. The manager or senior member of staff will monitor the behaviour of customers to ensure that there is no crime and disorder and that the conditions of the Licensing Act are complied with.
- 4. All electrical system at the premises, including portable appliances will be inspected and tested annually by a competent person to ensure safety. (The installation will have a full inspection at least every 3 years and be tested annually. A competent person will be a qualified electrician who is qualified to complete works as per the I.E.E. wiring Regulations 16th Edition or is registered with the ECA or NICEIC).
- 5. Where temporary electrical equipment is to be used, a suitable circuit breaker device will be installed to cover this equipment.
- 6. The circuit breaker should operate at a current not exceeding 30 MA and should comply with BS 4293.
- 7. The device will be tested monthly and tests will be recorded.
- 8. Temporary electrical wiring and distribution systems will not be installed unless inspected by a suitable qualified electrician. Temporary electrical wiring and distribution systems will comply with BS 7671 or where applicable BS7909.
- 9. The gas system including appliances will be inspected and tested by a Gas Safe Registered Gas Engineer annually and a satisfactory gas safety certificate will be obtained.
- 10. All safety certificates and inspection reports will be kept on site and made available for inspection by officers or relevant statutory bodies.
- 11. All external doors and windows will be kept shut where possible, other than for access and egress, in all rooms when events involving amplified music or speech or other entertainment likely to give rise to noise are taking place.
- 12. The interior and exterior lobby doors will be kept shut where possible, other than for access and egress, when events involving amplified music or speech or other entertainment likely to give rise to noise are taking place.
- 13. All persons under the age of 18 will be accompanied by an adult at all times when on the premises.
- 14. The AWP and cigarette machines will be sited in close proximity to the bar counter in order that they can be observed by bar staff.

I write with reference to a public notice as printed in the local newspaper on the 23rd September 2016.

It is with some long deliberation that I wish to object to the proposals put forward by Punch Taverns Plc on the following grounds:

- a) The very late hour of closing that has been requested would not be suitable for the built up area that the pub serves because of the noise caused by the music and departure of the public. It is tolerated at the times of special events like the Folk Festival week, but would be a nuisance on a regular basis. I am aware that there have already been some recent incidents where the police have been called out.
- b) I would hope that Punch Taverns have to prove to your satisfaction that the facilities available on their campus are suitable for the increased numbers they hope to attract. In my view 10 car park spaces & 2 for disabled is not adequate, therefore it is likely that the overflow will use the residential area known as Balfours, causing congestion and difficulty for emergency services and a noise nuisance for the residents, many of which are of the older generation.
- c) The current licence does appear to be more than adequate and if there is a need for an extension, it does seem fair that the licensing authority has the opportunity to judge the application on its own merits, i.e. as they would need to for say The Folk Festival.

Following several phone calls from local residents to our office and reading through some of the representations received I thought I would be useful to include this note to clarify some aspects of the application being made by Punch Taverns Plc for The Balfour Arms.

The current manager Ron Miles has been using Temporary Event Notices to licence an outside area at the rear of the premises for alcohol sales and entertainment and recently approached the Licensing Authority and Environmental Health Team with a request to permanently licence the outside area. As a result it was determined that Punch Taverns would need to apply for a new licence for the whole premises to include the outside area to replace the existing licence.

In consultation with the Environmental Health Team it was agreed that all outside licensable activities would cease by 11pm every night.

The closing times applied for in the new premises application will remain the same as the existing licensing hours apart from Maundy Thursday, Christmas Eve and Boxing Day these existing extended hours have been removed from the new application and the premises would therefore close earlier on these days than under the current licence.

The opening hours have been extended in the morning to allow the premises to open earlier to serve breakfasts from 8:30am although alcohol sales remain the same with a start time of 11am.

The times for live and recorded music inside the premises have been extended by one hour on Fridays and Saturdays evenings to bring the timings in line with the alcohol sales.

- 1. A noise limiter will be installed outside in the garden area of the premises and the level set to the satisfaction of an Environmental Health Officer of East Devon District Council.
- 2. Prominent signs to be displayed at the premises directing customers who wish to smoke to go to the rear of the premises.
- 3. There will be a designated smoking area set up at the rear of the premises.

- 1. Membership of the Local Licencees Association will be maintained.
- 2. An incident/refusals log book will be kept at the premises which will store details about any incidents or complaints at the premises.
- 3. All staff to be trained in the prevention of underage sales to a level commensurate with their duties. All such training to be updated as necessary, for instance when legislation changes, and should include training on how to deal with difficult customers. The training should be clearly documented.
