<u>Move More Cranbrook – Sport England Place Partnership</u>

Update: Cranbrook Placemaking Group Monday 20th January 2025

General background

The Move More Cranbrook programme and steering group is the local mechanism for delivering the outcomes and associated projects of the long term partnership with Sport England.

This was established and embedded as a result of funding from Sport England through their Local Delivery Pilot scheme started in 2018.

Representation of the Move More Cranbrook steering group includes:

- Live & Move (Place Partnership team for Exeter & Cranbrook)
- East Devon District Council (officers and member rep)

- LED Leisure

- Wellbeing Cranbrook
- Public Health Devon
- Active Devon

The group is Chaired by local resident and physical activity champion Matt Rowett and is the forum for developing local projects to help tackle inactivity in Cranbrook.

Place Partnership Bid

The latest Sport England Strategy: Uniting the Movement, focussed more resources at local delivery, taking the learning from the Local Delivery Pilots. Extended funding for 'deepening' local place partnerships was announced in November 2023. Exeter and Cranbrook (Live and Move; Move More Cranbrook) embarked on local stakeholder engagement and ran a series of workshops in January/February 2024. This work helped to develop a 'Place Partnership' bid to Sport England to extend the partnership to 2028.

More people taking part in physical activity in Exeter and Cranbrook - Exeter City Council News

The revenue bid was successful and is worth c£2.3m over three years from April 2025 to March 2028. This seeks to enhance and strengthen the partnership work to date and embed long term physical activity strategy in Exeter and Cranbrook.

Specifically, the outcomes are to continue to:

- Tackle physical inactivity
- Embed active lifestyles in local policy and across different sectors
- Tackle inequalities through more people being more active

The resource will provide ongoing funding in Cranbrook for:

- Project Management capacity
- Move More Cranbrook priorities to support families to be active
- Connecting Communities through Wellbeing Cranbrook
- Supporting aspirations to increase Active Travel in Cranbrook
- Share the learning and identify opportunities to scale work across East Devon

Sport England wish to see local investment to support the long-term sustainability and local ownership of the work. One way of embedding the work in East Devon beyond Cranbrook could be through sharing the learning and influencing policy/programmes/approaches across the district but no decision has yet been taken by East Devon District Council as to how take this forward.

Highlights of the work to date

The partnership between Exeter City Council, East Devon District Council and a range of local stakeholders, including Cranbrook Town Council, has developed a strong local Move More Cranbrook network, committed to tackling inactivity and improving active lifestyles in Cranbrook. During the current funding period 2019 – 2024 there have been some notable successes achieving significant impact in Cranbrook:

- Events in partnership with **Cranbrook Running Group**, a colour run and Santa Run attracting over 100+ participants
- Working in partnership with Cranbrook Education Campus and Devon County Council, establishing EX5 Alive, a family hub offering wellbeing, activity and general life skills support to families in Cranbrook
- Establishing Wellbeing Cranbrook with a new Community Connector (wellbeing referrals) and Community Builder (social action projects)
- £20,000 contribution toward the **Pump Track** construction and organising launch with Cranbrook Town Council
- Establishing a Community Grants programme
 - 21 projects funded since 2020
 - £49.000 awarded
 - o 100's of residents engaged
 - Cranbrook Running Group, Cranbrook Strollers, CEC, LED, Exe Nordic Walkers amongst range of community groups and organisations delivering to a wide range of ages/demographics.
- Sport England capital investment towards Ingrams Pavilion
- Funding and delivering Town Centre Consultation for future active community use

Alongside this there is a vibrant activity programme in the Country Park, an established Junior parkrun, emerging strong local community sports club and groups, and effective partnership work with both schools. Collectively the impact

across partners, as well as Move More Cranbrook activity is significant and the town should be proud.

Local Active Lives Survey

The impact of physical activity and wellbeing levels is tracked annually through the delivery of a Local Active Lives survey. Over 2000 residents across Exeter priority areas and Cranbrook are consulted using a local bespoke version of the national active lives survey.

The 2024 survey has highlighted:

- Continued reductions in inactivity levels
- A narrowing inequality gap for both women and people from ethnically diverse backgrounds
- Single occupancy car journeys remain at high levels in Cranbrook compared to Exeter and the national average

The data and analysis provides real time granular insight into physical activity trends at LSOA level across Exeter and Cranbrook. This is a novel, unique and academically robust way of tracking physical activity levels to help inform and evaluate the work at population level.

Through the Place Partnership bid we have secured resource to continue the local active lives survey until 2028, which will then provide 10 years of quality local data.

Wellbeing Cranbrook

New roles were created in Cranbrook in 2021 to develop a Wellbeing Cranbrook model as part of Wellbeing Exeter. The story of Wellbeing Exeter and recent impact and resources for Wellbeing Exeter and Cranbrook can be found here: lmpact | Wellbeing Exeter | Exeter

In March 2024 East Devon District Council committed funding to sustain the Wellbeing Cranbrook posts for the 2024/25 financial year subject to a number of conditions being met. The posts were hosted by Exeter Community Initiatives, who are the organisation that host all the Community Builders in Exeter.

An MOU has been drafted to formalise the partnership between East Devon District Council and Exeter City Council to deliver the Wellbeing Cranbrook model.

From 1st April 2025 a new local delivery partner is sought to host the roles and continue the impactful work of the Wellbeing Cranbrook model. Additional local

financial resources are required to match fund the Sport England Place Partnership funding to extend and embed these roles in local health and community settings.

Governance

The Move More Cranbrook Steering Group will continue to meet quarterly to help shape and deliver the operational programme required to meet the outcomes of the Sport England Place Partnership.

To strengthen the governance it is proposed that the Move More Cranbrook Steering Group will report regularly to the Cranbrook Placemaking Board to help shape future priorities and proposals of the programme and also, critically, to align with the strategic direction of the town and wider ambitions for the place.

The MOU with Exeter City Council for 2024/25 provides a platform to further strengthen this relationship and deliver the outcomes for 2025 to 2028 and secure long-term legacy from the investment and progress to date on improving active and healthy lifestyles in Cranbrook.

Cranbrook Public Transport

Present public transport position

Cranbrook is presently served primarily by Stagecoach service 4. This is operated entirely commercially, i.e. the service does not require financial support from Devon County Council.

Service 4 operates seven days a week and provides a direct link from Cranbrook to Honiton Road, Heavitree, Exeter City Centre, Exeter St Davids Station and Exeter University, offering access for education, retail, health and work (i.e. Exeter Logistics Park, SkyPark, Science Park, Sowton Ind Estate, RD&E Hospital, the city centre and University campuses):

- Monday Friday 12-minute peak frequency, 15-minute off-peak
- Saturday 15-minute frequency
- Sunday two journeys per hour
- First journey from Cranbrook 0445
- Last bus from Exeter City Centre 2345

Services 44/44A from Honiton and Ottery St Mary operate via London Road at least hourly Monday – Saturday.

The present frequency is the best of any settlement into Exeter in terms of frequency and spread of the day, this being more frequent than services from Exmouth, Newton Abbot and Tiverton.

Most settlements around Exeter have one route into the City – for example Tiverton, Cullompton, Crediton and Ottery St Mary. Only larger towns such as Exmouth and Newton Abbot have more than one route, with those being at lower frequencies. This reflects the present approach of having simple, frequent routes, rather than low-frequency variations.

In addition to the bus service, Cranbrook has a rail service with an hourly frequency to Exeter and London Waterloo, offering a highly competitive 9 minute journey time into the city centre.

Future development of public transport

As part of its Bus Service Improvement Plan, Devon County Council is installing intelligent traffic control through Heavitree and extended peak bus lane operation times to improve bus journey time reliability.

Cranbrook will also benefit when the service will be converted to operation by electric buses later this year.

The new developments in Cranbrook include S.106 funding to improve the service and increase its coverage, reaching the new parcels that will also see in time the delivery of a spine road linking London Road to Cranbrook railway station.

The present vision would see the service frequency increase to every ten minutes which would allow alternate journeys to operate via Bluehayes or the present route via Younghayes Road and then operate a loop around the Cobdens and Grange developments. The Treasbeare development would be served by an improved service 44, or an extension of service B from the Science Park (see illustrative plan appended).

The longer term aspiration for the rail line is to secure a 30-minute frequency between Exeter and Honiton (including Cranbrook); however, this will be dependent on significant national Government investment to deliver sections of double track between Honiton and Exeter.

Cranbrook future developments, access points and future contributions.

Cranbrook is envisaged to materially grow as a settlement for a number of years based on the adopted Cranbrook Plan. The allocated expansion areas are obligated (though the IDP and secured through s106 agreements) to pay proportionate financial contributions towards public transport enhancements whilst aiding the delivery of pedestrian, cycle and bus links and services as part of their design plans. The detail/triggers of which for the s106 agreements that have been signed (Cobdens and Treasbeare to date) can be found in the planning portal.

Not only will this help encourage and promote internalisation of trips in the town assisted by the development of the town centre and as neighbourhood centres evolve and develop. Through the growth, permeable and accessible routes for public travel across Cranbrook and to wider areas will be created. An example of this is highlighted in Policy CB24 of the Cranbrook Plan which will see the delivery of (along with the help of the build out of the expansion areas) non-motorised user routes across Cranbrook, broadly following London Road and subsequently feeding into wider pedestrian/cycle networks.

DCC has been heavily involved, particularly over the past year in creating a concept design for this vision of how Cranbrook will look in time, where further dialogue and collaboration with relevant stakeholders is anticipated to move this scheme forward in the future.


Allocated expansion areas within the Cranbrook Plan are also (following extensive discussions with DCC) delivering traffic calming measures on London Road, not only to materially reduce vehicle speeds but to also create a harmonised environment with non-motorised users that will aid in achieving an integrated community of Cranbrook, interlinking new and existing parcels.

The nature of vehicular access points put forward in the planning process are designed by applicants/developers. Whilst DCC are usually consulted on the intended proposals at early stages, we are not primarily a design service, yet we seek to ensure that what is delivered enables the public highway to operate effectively and safely, complying with the relevant design standards. This is aided by understanding the traffic impact for respective proposals through transport assessments and traffic modelling and relevant policy compliancy.

Having multiple controlled/signalised arrangements in close proximity can compromise the operation of the primary road arteries that are seen as corridors of movement, carrying much higher volumes of

traffic. A balance needs to be achieved between areas serving a place function and those providing a strategic movement function. Larger schemes expected to come forward as part of the Cranbrook Plan are likely to see more than one vehicular access into and out of the sites, which will shape the nature of accesses and the crossing facilities that may be considered necessary. The type, whether a refuge, a zebra crossing or signal controlled will need to take into account the likely pedestrian demand and potential desire lines as well as the volumes of traffic on the main route.

It is important that a balance is struck for London Road in providing permeable access for non-motorised users in line with the masterplan for the future build out of Cranbrook and its vision, while also seeing London Road having resilience to serve as a secondary relief road whether there are issues on the main local route through the town or in the event that the A30 bypass is temporarily closed.

Background and Context

The Terms of Reference for the Placemaking Group include a specific objective as follows;

To develop an Implementation Plan for the delivery of key assets and services in the town and ensure that the Implementation Plan includes a clear understanding of the following in relation to individual assets;

- the strategic business case;
- who the client is;
- the business plan;
- the brief and specification;
- the budget and funding package, including sources of funding;
- procurement strategy;
- project management and delivery;
- ownership and management of facilities;
- the ongoing service delivery model and associated costs.

Framework

Looking forward the following are considered to be some of the key events during 2025;

- A final investment decision being taken in relation to the district heating interconnector project
- Completion of a delivery plan for the town centre and the establishment of project teams for key town centre projects
- Delivery of Cranbox

These are significant events in themselves and collectively are of seminal importance in terms of how the town will develop and be governed going forward. It therefore stands to reason that the Placemaking Group will need to be sighted on and input to key decisions, for example through input to draft reports or responses to planning applications.

Topics

Alongside specific events there are also recurring topics which are sufficiently strategic as to demand the attention of the Placemaking Group. The provisional list of items for the next year is outlined below;

- Management of greenspace including suitable alternative natural greenspaces
- Health and wellbeing provision the links to potential availability of funding from the One Public Estate programme and other to progress the Health & Wellbeing Hub concept
- Town centre including the delivery of Cranbox, the Tillhouse building, leisure centre and wider masterplan
- Devon County Council related infrastructure this includes the proposed community facilities, transport and education improvements
- Sport England Place Partner status

It is anticipated that reports on specific topics will be scheduled into specific Placemaking Group meetings.

Local Infrastructure Fund

There is a long history of revolving infrastructure funds being utilised in Cranbrook to accelerate the delivery of critical infrastructure. This is an important cash flow tool and one which is likely to become ever more essential for coordinating infrastructure delivery for the expansion areas of Cranbrook.

East Devon District Council's Cabinet considered a series of reports focused solely on Cranbrook in July 2022. This included proposals to establish a £40m Local Infrastructure Fund. It is essential that this Fund is now operationalised in the form of bringing forward specific investment proposals. This is an intensive process as it will require an understanding of the detailed delivery of large-scale capital projects and the mechanism through which funds will subsequently be recouped.

At present the following projects are considered to be strong candidates in terms of being essential infrastructure which, with the benefit of forward funding, will help to unlock development and achieve wider place making objectives;

- Upgrading of London Road to facilitate 30mph along its length
- Delivery of a health and wellbeing hub
- Delivery of a leisure centre
- Delivery of the next primary school

These are complex projects which will require dedicated time and effort to develop. There are other projects which could also be forward funded. The oversight of the Board will be required to guide the operation of the Local Infrastructure Fund.
